### NOTICE

#### ADMISSION PROCESS CONDUCTED BY STATE CET CELL, MAHARASHTRA STATE FOR MEDICAL/DENTAL POST-GRADUATE COURSES THROUGH NEET-PG 2018 / NEET-MDS 2018

NEET-PG 2018/ NEET-MDS 2018 examinations for admission to Medical/ Dental postgraduate degree and diploma courses will be held online on 07/01/2018 by National Board of Examinations (NBE), New Delhi. The seats in Government/Corporation/Unaided Private Medical and Dental institutions in the State of Maharashtra shall be filled by using the merit list of NEET-PG 2018/NEET-MDS 2018, by the Competent Authority, State CET cell Maharashtra. The Eligibility Criteria for admission to these post graduate courses in Maharashtra State are as follows:

- (i) The Candidate must be an Indian National.
- (ii) The candidate should be a domicile of State of Maharashtra.
- (iii) A) All candidates, who have passed final M.B.B.S. or B.D.S examination and completed or completing one year internship training by 31<sup>st</sup> March of the year in which NEET- PG or NEET-MDS is held, from a recognized Medical or Dental college included in the Schedule appended to the Indian Medical Council Act, 1956 or from the Schedule appended to the Indian Dentists Act, 1948 and situated in Maharashtra, are eligible. The Medical or Dental College should have been affiliated to the Maharashtra University of Health Sciences or affiliated to the Deemed University established as per University Grants Commission Act, 1956 and situated in the State of Maharashtra. The candidate who has obtained registration either from the MCI or the DCI or respective State Council shall be eligible for

admission to Postgraduate Medical and Dental Course, subject to fulfilling the eligibility criteria of the NEET-PG or NEET-MDS Marks/percentile.

**B) Exception for clause (iii) (A)** - Candidates who are domiciled in the State of Maharashtra and who have obtained admission under 15% All India quota for M.B.B.S. or B.D.S. course in the medical or dental college situated outside Maharashtra State and who have obtained the degree from a University situated outside the State of Maharashtra shall also be eligible for admission to postgraduate Medical and Dental courses, subject to the merit of the NEET- PG or the NEET-MDS marks / percentile, as the case may be.

**C) Exception for clause (iii) (A)** - Candidates who are domiciled in the State of Maharashtra and who have obtained admission for M.B.B.S. course in the Medical college of All India Institutes of Medical Sciences (AIIMS) or Central Government Institutions shall also be eligible for admission to postgraduate Medical courses, subject to the merit of the NEET- PG marks / percentile, as the case may be.

(iv) Non Resident Indians (NRI) will be eligible for NRI quota only.

(v) Persons of Indian Origin (PIO) or Overseas Citizen of India (OCI) shall not be eligible.

(vi) The criteria for NRI in the State of Maharashtra, is as per Maharashtra Act XXVIII of 2015.

(vii) The orders issued by Government of Maharashtra with reference to admission process from time to time will be implemented and binding.

All the NEET-PG/NEET-MDS candidates desirous to take admissions in Maharashtra should take note of these criteria. The detailed rules for post graduate admission process in Medical and Dental courses and preference form brochure will be published in the due course.
